ORGANIZATION

Marpole-Oakridge Community Association (MOCA). MOCA formed on the 8th of February 1944 with the purpose of raising funds to build a community centre to provide "recreation for the whole family". It is a registered non-profit society.

The MOCA Board of Directors operates the Marpole-Oakridge Community Centre (MOCC) under a joint-operating agreement (JOA) with the Vancouver Board of Parks and Recreation.

Operation of the community centre is under the purview of the Vancouver Board of Parks and Recreation staff while MOCA provides governance in support of the goals and objectives of the community.

MISSION STATEMENT

To offer diverse opportunities to enhance the well-being of individuals and families and strengthen a sense of community in a safe, welcoming and accessible environment.

LINK TO THE ORGANIZATION'S MISSION

The Board of Directors are committed to ensuring that creative and innovative social and recreational programs are delivered to the community. As such, Board members work on one or more of the Committees of the Board with members of the community. Meetings occur monthly or as needed.

GENERAL BOARD SKILLS

- Understand, support and develop the mission, goals, objectives, programs and needs of MOCA.
- Governance: Ensure legal and ethical integrity and maintain accountability.
